

DNB National Bank Electronic Account Statement and Check Image Delivery Enrollment

TERMS AND CONDITIONS

- A working connection to the Internet with email capability to open .PDF files is required. The email you receive will be password protected using 128-bit encryption.
- At the time of enrollment you provide us with a case sensitive eight (8) character password consisting of numbers, letters, and special characters (*#@&%/!).
- Periodically, as required by regulation or Bank policy, the following disclosures and notices may be provided electronically with your e-statement: Privacy notice; revisions to account disclosures including but not limited to Terms and Conditions, Electronic Funds Transfer disclosure, Truth In Savings disclosure, and Common Features-Limits and Fees disclosure; customer education materials and other disclosures or notices regarding changes in deposit or loan products and services. You may request paper copies by sending your requests to the address provided below. Bank may charge a fee for paper copies based on our regular fee schedule.
- You agree to keep us informed of any change to your e-mail address by contacting us.
- Upon receipt by us of an email delivery error regarding the statement .PDF file, this agreement will be terminated if we are unable to contact you. The information contained in the undeliverable file will be mailed to you at the address contained in our records.
- If we change the minimum hardware or software requirements, and you are unable to receive electronic delivery services, you will be released from this agreement without any penalty or consequence to you.
- You may withdraw your consent for electronic delivery services by sending written notice to the address provided below. Upon withdrawal, the documents will be sent in paper form to your address of record.
- Following termination of the electronic delivery service by either party, a new enrollment agreement will be required to reinstate this service.
- Upon transmission of the email file to your email address, you will have the sole responsibility for maintaining security of the email including, but not limited to, your email provider and users of your personal computer or computer network.
- You further agree to indemnify and hold us harmless from and against any and all loss, cost, damage, liability, or exposure (including reasonable attorney's fees) that we or you may suffer or incur as a result of the unlawful use, unauthorized use, or misuse by any person of any such email or electronic delivery of a statement. You shall bear the entire risk for unauthorized use thereof whether or not you are negligent.
